**COMMONS ACT 2006  
COMMON LAND REGISTERS UPDATE**

North Yorkshire County Council is a Commons Registration Authority under the Common Act 2006.

As part of our responsibilities under the Act, we have been asked to review the registers of common land for the county. These registers show who holds grazing and collection rights over common land.

In the majority of cases, the register has not been updated since the creation of the Commons Registration Act 1965, so many of the details we hold may be out of date. We also appreciate that the reference to some names and address may be upsetting to some people.

Our records show Reighton Parish Council is the owner for common land unit ER (CL 86), (CL 87), (CL 88) (piece of land at Speeton, piece of land adjoining St Helen's Lane and land at the south end of Rotten Row in the Parish of Reighton).

If you think this record is not accurate then you can ask to have the register updated. To update the register you would need to provide us with proof of ownership such as a Land Registry Title certificate and coloured plan.

Register entries and maps are available to view free of charge, by appointment, at County Hall, Northallerton. If you would like to make an appointment, or have any questions about the Common Land Register, please contact me on the email address or telephone number above.

If you are not the person named in this letter we would appreciate it if you could let us have any contact details you may have for them.
